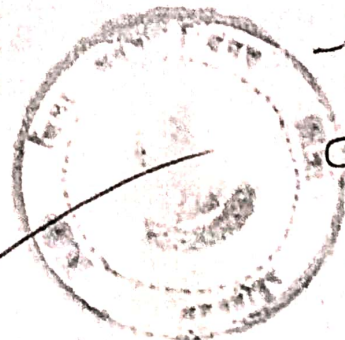

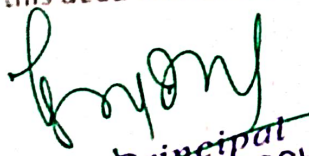

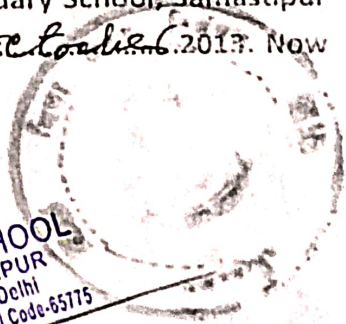

- 1) That in view of the said desire of the settler hereby trust and assigns to the trustee. - 2) That trustee shall establish and construct institution school out of the money settled and propagate for achieving and strive for aims and objective given above.
- 3) That trustee shall raise fund and augment the movable settle to them for achieving aims and objective. The fund may be augment by them from contribution subscription endowment charity donation or by any other means which may be found legal and moral.
- 4) That the trustee may derive income from managing the fund arising out of the settlement made by the settler and augment if any which may be called in this deed as trust fund save from the profit and loss account of the trust.
- 5) That the profit and loss of the trust shall be computed the end of each financial year and the audit of account may be conducted by external auditor.
- 6) That the present Chairman and managing trustee of the trust is Md. Rashid who hold said office for Ten (10) year and after lapse of 10 year Md. Ishteyaque Anwar shall hold office of managing trustee or chairman of the Trust. The settler has given this decision willingly.
- 7) That the power and function of trustee is the same but the trustee who is holding office of Managing Trustee or Chairman of the Trust shall represent the trust before any Government office or body corporate for purpose of enhancing the aims and objective of the trust.
- 8) That the trust shall envisage its own rule regulation and byelaws in furtherance of their aims towards achieving aims the trust.

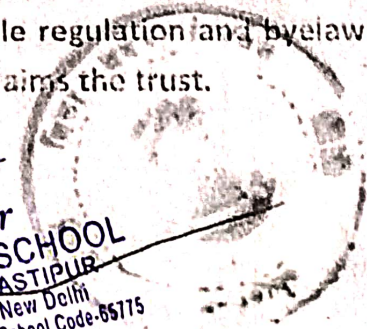

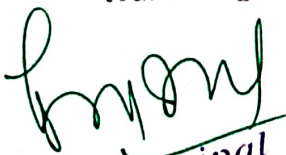

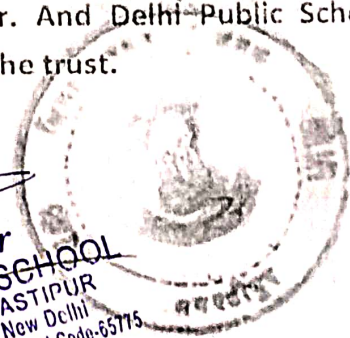


- 9) That the properties of the trust shall be run in the name of trustee and trustee shall exercise ownership over such property moveable or immovable and the trustee may exercise the veto against decision of Executive in the interest of aims of trust. On exercise of such veto decision of the Executive shall be reviewed and made in consonance of the will and desire of the trustee. Executive means member of managing Committee.
- 10) That the trust may collaborate with any other association body corporate, Non-Government organization, Co-Operative or Government institution for purpose of enhancement of it's aim".
- 11) That the trust may amalgamate with any other trust society registered under society Registration Act, Company Registered under Companies Act or any other legal person and also may amalgamate in it's fold other society registered under Society Registration Act, Companies registered under companies Act or trust registered under Indian Registration Act.
- 12) That if one the trustee voluntarily desirous to resign from the trust and expresses not to participate in their activity of trust and his family member also not ready to join trust in place of such trustee then the remaining trustee may induct any trustee in place of said outgoing trustee after executing rectification deed of amendment in this deed.
- 13) That any amendment in the clause of this deed may be made by unanimous decision of the trustees but such amendment shall book place only after execution and registration of rectification deed in the registration office of appropriate jurisdiction. But no such amendment shall militate with the aims and objective of this deed.
- 14) That this paragraph of the deed is schedule containing it's managing committee formed for purpose of and present the statement of the same before General body management of school run by this trust under name and style of Delhi Public School Muktapur. And Delhi Public School Warishnagar. District, Samastipur {Bihar} of the trust.
